## Elizabeth Shaffer, MPRB District 4 Park Commissioner –

- Elizabeth discussed the Cedar Lake closure and that MetroTransit will pay "easement fees" to the Park Board – the plan is to remove more buckthorn. Some volunteers may be needed although it does have funding. There will be additional landscaping. Amanda V agreed to follow up with Keith **Prussing**.
- Mark Schmidt from CLPA suggested (at the Fishing Event) that CIDNA try to do some programming in the area near the fishing pier (there is an open area with picnic tables). For now, CIDNA doesn't have the bandwidth to take on something new.
- Wedge Neighborhood is getting a new park at the small triangle where the entrance to the bike trails north of Franklin

## Noah Cameron, NRP Policy Board Member

 Noah introduced himself. He is a volunteer in this role – also involved with LHNA. He is new in the role. He did mention that the 70% rule to use/reuse NRP funds for housing was removed. This is related to the re-allocation of old funds that were used and repaid.

## Update on Adopt-a-Drain – Alex D

- Alex shared that Pat H, Tim, Alex and Patty have been actively working to get the word out.
- Six NNO celebrations were visited by Pat, Patty and Alex with a short presentation and QR codes handed out. Patty doorknocked on Park Lane. Pat put up and took down some "Adopt Me" signs - we will continue to

put them up and take them down throughout the neighborhood. From what Alex and Pat learned, there isn't a simple way to get updates on drain adoption.

- Alex reminded us that we lead by example. Our board (Alex/Patty, Tim, Amanda) collectively adopted 10 drains. At July meeting a goal was for 100% participation on the board to adopt at least one drain. Mike S/Laura D/Steve G please report on your drain adoption plans
- Patty is following up with the city on stenciling drains, and if there is equipment for cleaning them. Pat and Tim went to a meeting where CIDNA received some equipment (small rakes, buckets, grabbers) – waiting to hear how CIDNA should use them and if they can be distributed to drain adopters as we received 8 or 10 – Pat and Tim to discuss and opine

# Follow up on neighborhood collaborations (Forum & Fishing events) – Amanda

• Event was successful – 40 – 60 people fished. This event will be repeated on Saturday, August 9, 2025

# Meetings on the Move (Amanda Vallone)

- September meeting is planned for Pavilion at Bde Maka Ska. Katie

# Update on Super Sale in September (Amanda)

- This year CIDNA is participating in the collective sale for free (other neighborhoods are paying \$200) – to date we have only 2 sales in our neighborhood – flagging that there is a lack of interest from CIDNA so that next year when we are asked to take part we are aware that it would not be worth it for CIDNA to pay \$200 given neighborhood interest
